slavery using the appropriate reporting channels and will support anyone

who acts in good faith.

Boomerang SA's recruitment, rewards and remuneration procedures and

policies supports its efforts to combat modern slavery and human

trafficking.

Boomerang SA will continue to develop its commitment to combat modern

slavery and human trafficking and will outline such activities within its

annual anti-slavery and anti-trafficking statement.

Any breaches of this policy may result in Boomerang SA taking disciplinary action

against individuals, reporting the matter to the authorities and terminating its
